TERMS AND CONDITIONS

General: This license constitutes the entire agreement between you and the CCHP of The University of Akron concerning the licensed use of the materials you select. Fee Structure For Moving Images:

Commercial licensing fees include research and digitization costs. Personal research use and non-commercial use licensing fees do not include the CCHP’s \$20.00/hour research fee.

- Non-commercial use \$5.00 per minute, access limited to 7 days
- Commercial use \$75.00 per second per use with a minimum of \$75.00 per title
- Commercial electronic use \$75.00 per second per use with a minimum of \$75.00 per title
- Commercial multiple use license \$150.00 per second per project

(The commercial multiple use license is reviewed on a case by case basis during the application process includes showing the segment: *multiple times in the same venue/one or more times in a repeated workshop instance/worldwide derivative works for the life of the project*).

Fee Structure For Sound Recordings:

The following fees do not include the CHP’s \$20.00/hour research fee.

- Non-commercial use \$2.50 per minute, access limited to 7 days
