For Retiree Dependents whose University health insurance is terminating on December 31, 2020, this is a reminder to get new insurance for January 1, 2021.

Those with Medicare coverage can get a supplement for original Medicare or a Medicare advantage plan. The open enrollment for Medicare is October 15 to December 7 in order to get insurance starting on January 1, 2021.

The Medicare website listing different plans for Ohioans for 2021 is up and running.

Open enrollment for the Affordable Care Act is November 1 to December 15.

We do not know the status of those retiree dependents who were considered bargaining unit members, but if their retiree dependent insurance is terminated, they have 60 days to get new insurance.

- **D. Scholarship.**Dan Sheffer reported for Carl Lieberman. As of June 30, 2020 the assets in the AUAR Scholarship fund totaled \$118,359.51. Scholarships were awarded to three students for the 2020-2021 year: Christina Berube \$2500 in Fall/Spring; Mikayla Brown \$1250 in Fall; and Emily Taylor \$1250 Fall.
