#### **MBA CONCENTRATION**

3 or 4 courses 9 credits

Students selecting the Interdisciplinary concentration may use 9 credits of medical school coursework to fulfill this requirement.

#### **MBA INTEGRATIVE**

6500: 695 Organizational Strategy 3 credits

#### MBA ACTION LEARNING

Approved courses from each department/concentration consisting of action-based activities may fulfill this one course program requirement. Other alternatives would include internships (excluding GATEWAY internship), study abroad, independent studies of various natures which are "live" projects, etc.

A student may fulfill this program requirement with a course taken in fulfillment of concentration requirements that is listed as an approved "MBA Action Learning" course. OR A student may fulfill this program requirement by taking an approved course which is outside of their concentration.

The Bioinnovation and Design course is recommended for second year medical students, which can be part of the Interdisciplinary concentration.

## MCAT/GMAT REQUIREMENT

The Graduate Management Admissions Test is required for admission. However BS/MD students may submit the MCAT score for review. A score on all sections is expected. The writing component is <u>required</u> and an essential metric for admission into the MBA program.
