Dear Accounting Student:

We would like to encourage you to apply for a School of Accountancy scholarship. The deadline is February 25, 2008. Applications should be taken to Sharlene Husk in the School of Accountancy's main office, CBA 254. In the past, we have awarded over \$100,000 to outstanding accounting majors. Normally, you should apply if you satisfy the following criteria:

1. you are an accounting major;
2. you have a GPA of at least 3.0; and
3. you will be attending classes in Fall 2008.

If you are graduating in Spring, Summer or Fall 2008, you might be eligible for a CPA Review Scholarship. We have several CPA review scholarships that are available to outstanding graduating students.

In exceptional circumstances, accounting majors with strong documented need and GPAs of less than 3.0 have received School of Accountancy scholarships. If you plan to apply for a need-based scholarship, you should describe your need very clearly in the application form. Normally the competition for these need-based scholarships is very high and only a small number are available.
