

Class of 2008 Employment Report

Of the 148 graduates in the Class of 2008, the employment status for 145 (98%) is known. Of the 145 individuals whose status is known, 119 reported being employed. Using the NALP formula for calculating employment 82.1% of graduates were employed 9 months after graduation.
