WORKS IN PROGRESS

Coupons After CAFA: Judges, Once More, into the Breach – Explores Congress's statutory protections for coupon settlements, suggests that CAFA's ambiguities thrust the burden back on district court judges to determine coupon protections, and reviews available CAFA decisions that show (1) a strong movement to construe the statutory provisions to protect absent class members in the coupon settlement context, as well as (2) a persistent strain of cases that find ways to evade heightened protection

A Triple Play on Absent Class Members: Imposition of Bonds to Impede Appeals by Class Action Objectors – This will be a short essay to discuss a phenomenon that I have seen in some district court cases. It is, of course, typical that, when class counsel and defendant's counsel settle, they lose their adversarial status. Objectors will sometimes fill that void and attack portions of the settlement and/or attorneys' fees. In a segment of cases, class counsel and defense counsel have also teamed up to request that the court impose a bond before objectors may appeal. I will conclude that the legal basis for these bond requests is not solid and that it presents due process problems as well.
