NOTES FROM FACULTY SENATE 6 February 2025

• Chair remarks:

- The new version of the Higher Education Reform Senate Bill 1 (SB1). And House Bill 6 (HB6) is moving quickly through the legislature. Senators and faculty encouraged to weigh in.
- Rethinking Race to be discussed later
- o ICE protocols were distributed for consistent response on campus
- Search committee for Provost was being formed

In the absence of the president we heard only from the provost

The publicized cancellation of Rethinking Race (RR) was discussed at some length. There was no event scheduled for spring and the 2025-2026 budget is not yet created. There was no plan to include RR in the upcoming budget. The decision was made prior recent news out of Washington. Best described as in transition. (NB: Public letters from the Trustees Chair and the President were not available as of the meeting.)

Committees

- Discussion from the prior meeting regarding "interim grades" was followed up with a proposal to simplify the process to simply assigning NC (No Credit) to those students who were not making adequate progress by roughly 1/3 of a term. That grade would ultimately be replaced by the course grade. Students would be notified to consult instructor and/or advisor.
- The recommendations for General Education revision are to be voted on in March. In general: a First Year Seminar that can be discipline-specific would be included; Arts/Humanities requirement to drop from 9 to 5 credits; Speech to be recommended rather than required.

Other

- AAUP is working through retrenchment with administration. Also recommended speaking up regarding SB1.
- USG and GSG reported activities. USG hosted Ohio Student Governments on campus.

New business

 The Senate voted in favor of a resolution to bring back Rethinking Race in calendar 2025, subject to legal considerations.
