# Message From The Dean

Dear Law Students:

Welcome back to our returning students and welcome aboard to our new ones. This is one of our largest entering classes and, as expected, they are bright, energetic, and excited. They will make good "alums-in-waiting" and, of course, alums in a few short years.

Over the past two years, the faculty has been considering a number of changes to our curriculum, and they will continue that process this year. One change is already evident - our restructured Legal Research and Writing Program [LRAW]. The revamping is in two parts. First, entering and future students will have three semesters of LRAW, with one semester focused on specific skills. The exact nature of that skills course, and the integration of skills into first year courses is still in the process of development. Dean Jordan is coordinating that effort and I hope to be able to report to you soon on what exactly is going to be done.

Next, we have added four new faculty, who will, under the direction of Professor Richard Cohen, be teaching the LRAW courses. Each of these new colleagues comes with years of experience and a skill set that we are confident will assist our students.

*Barbara Sanchez* graduated from the University of Akron, where she was Articles Editor of the Law Review and winner of five CALI awards. She worked as an extern in the United States Attorney's office and for  $6^{\text{th}}$  Circuit Judge, The Honorable Deborah L. Cook. *Ann L. Shiavone* is a graduate of Duquesne Law School, where she was first in her class and a member of the Law Review. 
## New Business Legal Clinic (NBLC) Opportunity

### CONNECTICUT BAR EXAM – UPDATE EFFECTIVE FEB. 2010 EXAM

The following message was received from Kathleen B. Wood, Administrative Director of the Connecticut Bar Examining Committee.

Please accept this email as notice that the Connecticut Bar Examining Committee recently voted to change the essay portion of its bar examination. Beginning in February 2010, up to ½ of the essay portion of the exam will be drawn from the Multistate Essay Examination as produced by the National Conference of Bar Examiners. As a result, the CT bar examination will no longer be administered on Wednesday and Thursday, but will instead be administered on Tuesday and Wednesday. Thus, it will no longer be possible to sit for certain bar exams concurrently with CT, such as NY; however, individuals will now be able to sit concurrently in other jurisdictions where this was previously impossible, such as MA. ## New Legal Intern Application -- OHIO

FROM THE SUPREME COURT OF OHIO BAR ADMISSIONS OFFICE -- Please be advised that the Supreme Court of Ohio has amended <u>Gov. Bar Rule II</u>, effective August 1, 2009. Among other things, this includes changes to the application for certification as a legal intern. In addition to the two documents required in the past, a certificate from the applicant's supervising attorney is now required.
