AkronLawJobs No. 8695 Overview: The United States Attorney's Office (USAO) for the Central District of California is responsible for representing the federal government in virtually all litigation involving the United States in the Central District of California. This includes criminal prosecutions for violations of federal law, civil lawsuits by and against the government, and actions to collect judgments and restitution on behalf of victims and taxpayers.

Duties: Assistant United States Attorneys (AUSAs) prosecute federal cases in the Central District of California and advise federal law enforcement agents on investigations, present cases to the grand jury, try cases before the United States District Court, and represent the United States in criminal appeals before the Ninth Circuit Court of Appeals. All initial attorney appointments to the Department of Justice are made on a 14 month (temporary) basis pending favorable adjudication of a background investigation.

Required Qualifications: Applicants must possess a J.D. degree, be an active member of the bar (any jurisdiction), and have at least 3 years post J.D. experience. If not already an active member of the California bar, any applicant hired will be required to take (prior to their entry on duty date) and subsequently pass the California bar exam. AUSAs must become active members of the California bar and maintain California bar membership.

Preferred Qualifications: Litigation experience, superior academic record, excellent writing skills, impeccable character, a demonstrated interest in public service, courtroom presence, and the ability to work with and relate to a wide variety of people are all taken into account. Most attorneys hired have several years of experience, although highly qualified recent graduates with some experience in practice or as a judicial clerk are also considered. Ties to the Central District of California will be considered.

Salary: AUSA pay is administratively determined based, in part, on the number of years of professional attorney experience. The range of basic pay is \$52,329 to \$122,784 plus locality pay where authorized.

Depending on what needs to be done in our cases at a given time, fellows should expect to do several of the following tasks while they are at OCFW: conduct legal research and draft pleadings; write motions and briefs; locate and interview witnesses; visit and interview clients; participate in case strategy sessions; locate, obtain, and organize documentary evidence; read and digest capital trial transcripts; conduct social science and other research; and locate and prepare expert and other witnesses to testify in evidentiary hearings.

Qualifications: Preferred: Demonstrated interest in indigent defense, excellent research and writing skills, and commitment to culturally competent representation. Ability to speak Spanish is a plus.

Persons of color and persons from backgrounds that are underrepresented in the legal profession are especially encouraged to apply.

Funding: Applicants should identify a primary source of funding, such as law schools or public interest fellowship grant-making organizations. The OCFW will assist applicants with funding applications.
