Application to Use Materials

In order to use documents, still images, moving images, or audio recordings (hereinafter Materials) from Archives and Special Collections of University Libraries at The University of Akron (hereinafter the Archives), an individual or organization (hereinafter Applicant) must complete this Application, read and agree to the Terms and Conditions, and pay all required fees. Please complete this form and either fax, mail, or e-mail it to the attention of the Archives at archives@uakron.edu.

The Terms and Conditions of your License for the use of Materials from the Archives are set forth below. Please read this License Agreement carefully and fill out all fields. By responding affirmatively below, you will be agreeing to be bound by the Terms and Conditions of this Agreement with respect to the Materials. Please note, approval may be required from The University of Akron's Trademark and Licensing counsel for some applications.

I plan to use the Materials (check all that apply):

- For research and personal use (i.e., examining the Materials for content with no intention of reproducing the originals).
- In a non-commercial publication or presentation (such as a scholarly article, conference proceedings and presentations, a professional newsletter, or for classroom use).

TERMS AND CONDITIONS

General: This License constitutes the entire Agreement between you and the Archives concerning the licensed use of the Materials you select. This License is governed by the laws of the State of Ohio and the United States of America. All rights to the Archives' Materials are owned by The University of Akron and its licensors, subject to the provisions listed below, and are protected by United States copyright laws, international treaty provisions, and other applicable laws. The University of Akron retains all rights not expressly granted by this Agreement. This License shall terminate immediately and automatically, without notice from the Archives, if you fail to comply with any of the Terms or Conditions of this License Agreement.

License: The Archives grants you the non-exclusive right to use the Materials only for the use indicated on the approved Application. For example, one use in a print book and one use in an electronic book constitute two separate uses and incur two separate fees. You are not permitted to use the Materials, or any portions of the Materials, in any other way. Permission is granted on a one-time use only basis and each separate use requires an additional fee. Publishers may also purchase a multiple use license, which includes use of the image in the following: *print/e-book/web/all manner of media/custom/derivative works/international student version/life of the edition*. You may not manipulate and/or alter the image in any manner. Regarding the online publication of Materials, the Archives reserves the right to grant permission based on the educational value of the site in accordance with the Archives' mission statement. Fee Structure for Moving Images:

The following fees do not include the Archives' \$20.00/hour research fee.

1. Research and personal use	\$0.45 per foot or vendor fees + costs
2. Non-commercial use	\$5.00 per second
3. Non-commercial electronic use	\$5.00 per second
4. Commercial use	\$45.00 per second
5. Commercial electronic use	\$45.00 per second
6. Commercial multiple use	\$90.00 per second

Fee Structure for Sound Recordings:

The following fees do not include the Archives' \$20.00/hour research fee.

1. Research and personal use	\$1.00 per minute or vendor fees + costs
2. Non-commercial/scholarly use	\$2.50 per minute
3. Non-commercial/scholarly electronic use	\$2.50 per minute
4. Commercial use	\$15.00 per minute
5. Commercial electronic use	\$15.00 per minute

Restriction: You must obtain written permission from the Archives to reproduce or publish reproductions of its Materials. Permission is granted once an Archives representative has signed the Application to Use Materials. Materials must be reproduced in their entirety. Materials may not be cropped, overprinted, or altered in any way without written consent of the Archives. The Archives reserves the right to examine proofs and captions for accuracy and sensitivity prior to publication with the right to revise if necessary. The Archives reserves the right to refuse any request and to impose such conditions as it may deem advisable in the best interests of the Archives.

Any person or organization granted permission to publish the Archives' Materials online is responsible for retaining the Archives and Special Collections watermark if it appears and for ensuring that the Materials cannot be downloaded. If these conditions have been violated by the Applicant, this License becomes nullified and legal action may be pursued by The University of Akron.

Assignment/Copies: You may not transfer or assign this License to a third party. You may not make copies, either digital or printed, of the Materials for the purpose of re-licensing or re-selling the materials (whether separately or in combination with other materials). You may not use the Materials for any other purposes except those indicated on the approved Application.
