1. Meeting Minutes

❖ 1991 an Ad-hoc Committee was formed to review insurance plans

- ❖ 1990's the Ad-hoc Committee became the Faculty Well-being committee
- ❖ 1998 the Faculty Well-being Committee was named University Wellbeing Committee and worked closely with the PBC.
- ❖ September 15, 2005 Faculty Senate adopted a resolution from the Well-being Committee related to the committee structure.
- ❖ November 3, 2005 Faculty Senate charged the Well-being committee with exploring committee structure.

CPAC agreed the Well-being committee needs reviewed for both structure and function and recommend:

- ❖ Equal representation of all employees on the committee
- Committee function to focus on well-being and health promotion NOT negotiating insurance plans.

CPAC agreed that the insurance plan negotiation is a budgetary matter not within the purview of the Well-being Committee.

- R. Cannon requested further recommendations be forwarded to her.
- R. Cannon will initiate a draft for a Well-being Committee to include CPAC recommendations.

## 6. Shared Leadership

President Proenza requested CPAC insight about shared leadership. Kent Marsden volunteered to draft a model for shared leadership.
