 - o The revisions to the Rule were proposed by the Contract Professional Advisory Committee (CPAC) in order to simplify the Rule. CPAC will create a procedural manual containing the specific operational details about this Committee and intends to post this information on the CPAC website. 3359-22-03 CPAC Rule was passed at the last Board of Trustees meeting. (August 3, 2011)
 - o Here is a brief summary **3359-22-03 Contract professional advisory committee**. (A) The contract professional advisory committee, "CPAC," shall serve as an advisory body to the president on matters relating to employment and any other issues for contract professionals and on matters relating to any other issues directed to the committee. The committee shall maintain one (1) Standing

Committee named The Contract Professional Grievance Committee, "CPGC" whose members are appointed from the CPAC membership. All other committees shall be of a "project charter" nature and be assigned as needs arise.

- (B) The committee shall meet with the president annually and prepare an annual report in June of each year for submission to the office of the president. A copy of this report shall be distributed to all contract professionals.
- (C) The committee shall call an annual meeting first meeting in July whereby the following (but not limited to) business must be conducted:
- (1) Appoint a Chair for the upcoming year;
- (2) Appoint a Vice-Chair and Recording Secretary;
- (3) Appoint Faculty Senate Representatives;
- (4) Establish meeting times and location;
- (5) Contact the President's office to appoint open positions;
- (6) Appoint open positions;
- (7) Appoint Grievance Committee (see Ohio Administrative Code 3359-22-04);
- (8) Appoint any Project Charter committee members as necessary; and
- (9) Verify ex-officio members by name(s).

New rule passed granting Contract Professionals and additional 20 days of paid leave. (a) 3359-11-02, Family and Medical Leave, Leave of Absence, Paid Maternity Leave, Paid Paternity Leave, Paid Adoptive and Foster Parent Leave, and Vacations for Employees Other Than Bargaining Unit Faculty

(b) O.A.C. 3359-26-04, Absence from Campus These Rules contain revisions pertaining to paid maternity and paternity leave and paid adoptive and foster parent leave, as well as language to conform to changes in the Family and Medical Leave Act. All of the proposed changes to these Rules are consistent with current provisions of the AAUP Collective Bargaining Agreement.
