# **Chair Update** – Presented by Max Fightmaster

The next step is to send the document to Sarah Kelly who will confer with John Riley.

### **Vice Chair Update** – Max Fightmaster

Max has had further discussion with Stephen Myers regarding the brick engraving costs. This expense may be
more costly than originally expected. There is a company that engraves bricks directly where they are placed vs.
removing and sending to an engraver and then resetting in the brick pathway. Max will check further to identify
possibly a funding source and the best way to proceed.

#### Report on President's Meeting / Letter to the President discussion – Gabor Smith

- Gabor met with CPAC reps to discuss the idea of writing a letter to President Miller requesting a salary increase for staff. CPAC will be waiting until their January meeting to discuss further. Ideas for SEAC moving forward include 1.) inviting President Miller to one of our monthly meetings, and 2.) crafting a survey to our constituents to create and collect data to present to President Miller.
